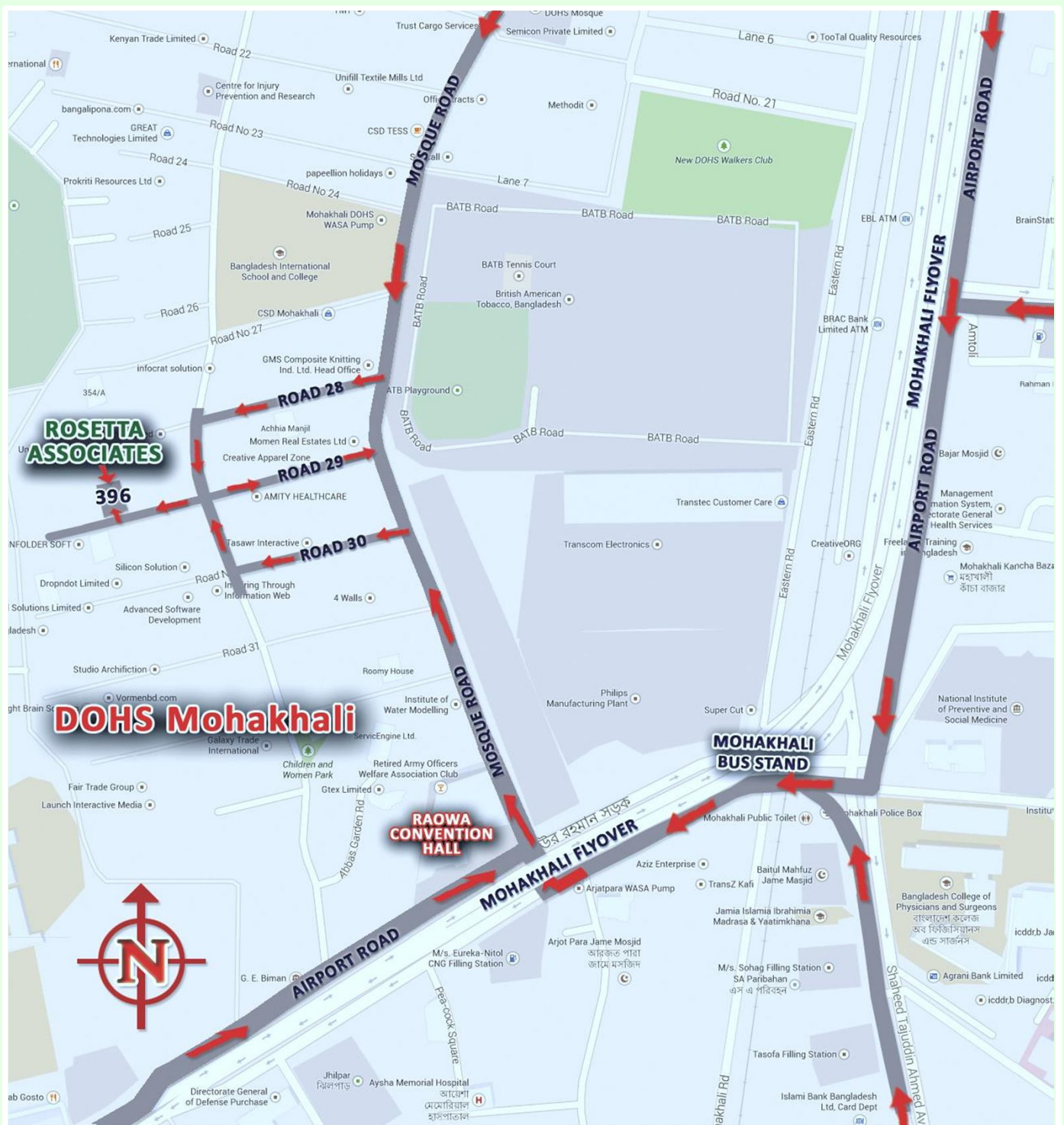


## Venue and Location Map
